Photo usage is determined solely by signed releases (adult model release and/or property releases) on file with 200pockets.com. Mindful of the legal constraints of media photography with a sensitivity to meeting the needs of artists, musicians, venues, fans and media.

## Terms of Use

For photographs taken at the Hotel Utah Saloon, San Francisco by Bridget Canfield (dba 200pockets.com)

- High resolution digital photographs (12MP, JPG, 360 dpi) available for sale - US \$30.
- Monies from each sale will be divided equally between the venue, our open mic host and our volunteer photographer/US \$10 each. This helps to mitigate the costs of running the Hotel Utah Open Mic website (<http://theutah.org>) as well as the travel and post processing expenses of our volunteer photographer.
- All those depicted in the image must sign an **adult model release/permission for photography form** and a **terms of use document**.
- The high resolution digital file can be used to make photo prints, used in a press kit, as CD album art, within a CD, derivative works, postcards, posters, web sites, web site galleries, and other promotional materials.
- Use in video or film requires separate negotiation with the Hotel Utah Saloon and the photographer.
- Where possible, photo caption – “Hotel Utah Saloon, San Francisco, California” requested.
